FINANCIAL OVERVIEW

During this financial year (Oct 2018 - Sept 2019) we raised RM 3,000,066. From this, RM 1,720,576 (57%) was raised from local sources, while RM 1,279,490 (43%) was from abroad RM 2,647,407 (88%) was funds restricted to specific projects, leaving only RM 352,659 (12%) for core operational costs and urgent initiatives.



Total expenditure for the financial year was RM 2,496,942. This comprised direct expenses of RM 2,005,402 and total operating expenditure of RM 491,540. This leaves a net surplus of RM 376,272. At the end of the financial year, our total asset was RM 639,777 and total liabilities were RM 254,416.

Promoting an Inclusive Malaysia



Championing for the Rare

In April 2018, IDEAS embarked on the "Championing for the Rare" project to advocate for a National Policy for Rare Diseases. Over the course of the project, IDEAS has successfully built strong relationships with stakeholders and contributed to the knowledge gap through three in-depth publications. The first publication was a position paper published in 2018. Subsequently, two papers were published in 2019: "Improving Access to Orphan Drugs in Malaysia" and "Whitepaper: Rare diseases in Malaysia". The second paper explores challenges faced by rare disease patients in accessing orphan drugs and proposes ways to improve patient access to orphan drugs. The final publication of the project features the findings of the two previous papers and proposes a policy framework for the consideration of the government.

Through concerted research, public engagement and advocacy, the project culminated with the successful inception of a National Rare Disease Framework and committee formed by the Ministry of Health, Malaysia in November 2019.



Effectiveness of State-Owned Trading Enterprises in Achieving Food Security

Food security is of vital concern to developing countries and various kinds of policy instruments have been employed to achieve stable food sources for growing demands. One of the most predominant policy instruments involves State Trading Enterprises, which are often utilized as a means to achieve agricultural policy objectives

such as stabilizing domestic prices, eliminating marketing inefficiencies and ensuring the availability of food supplies. In this report, IDEAS partnered with the Center for Indonesian Policy Studies to look into two case studies, BERNAS in Malaysia and BULOG in Indonesia. Both case studies have shown that the rice policies in Malaysia and Indonesia that were intended to achieve food availability and price stability have resulted in windfall losses to the industry.

In the case of Malaysia, it has created market distortion and gradual monopolies. As for Indonesia, it has resulted in welfare losses of the consumer due to the widening gap of the domestic and global rice price differential. This is IDEAS' second report on agriculture.

The Economic Impact of Granting Refugees in Malaysia the Right to Work

Malaysia hosts approximately 180,000 registered refugees and asylum seekers as of the end of 2019. As Malaysia has not ratified the 1951 Refugee Convention and refugees have no legal rights to work in Malaysia, most of them are at risk of exploitation and often work in dirty, dangerous and difficult jobs. This paper explores the economic benefits and costs in granting the refugees the right to work. We estimated that if given the right to work, they would contribute over RM3 billion to annual GDP by 2024. Furthermore, if we invest in the education for refugees alongside the local population, we will see an increase in their contributions to GDP to over RM6.5billion annually by 2040. There would be a substantial cost to invest in their education, but in return, they would be able to contribute significantly more to GDP. This paper has garnered attention on the issue and been widely cited since its publication.

DEMOCRACY AND GOVERNANCE Ensuring Trust in Institutions

Projek Pantau: Assessing the Fulfillment of Manifesto Promises

When the Pakatan Harapan coalition won GE14, all eyes were on its manifesto, *Buku Harapan*. In keeping with the spirit of reforms, openness and transparency of the new administration, IDEAS began Projek Pantau, a series of report cards evaluating the government's progress in fulfilling its manifesto promises. One notable achievement was when the Kuala Lumpur branch of the Parti Keadilan Rakyat invited us to present the second report card at their party convention in November 2019. We have released three report cards so far, with one more due in May 2020 to mark the 2-year anniversary of the Pakatan Harapan administration.



Continuing the Push for Institutional Reforms

In 2019, we played a significant role in further advancing institutional reforms. As part of the Governance, Integrity, Accountability and Transparency (GIAT) coalition, we met with the Caucus on Reform and Governance, chaired by Datuk Seri Anwar Ibrahim. We were also in the Bukit Aman Police Headquarters, meeting with representatives from the Jabatan Integriti dan Pematuhan Standard (JIPS) to share our work on protecting whistleblowers and anti-corruption. In addition, we were invited to meet with the Parliamentary Select Committee for Major Public Appointments, where we suggested concrete measures to ensure independence in the appointment process of public officials. The National Budget Office also sought our inputs in preparation for the tabling of Budget 2020. Lastly, IDEAS and other members of GIAT met with Tan Sri Ariff Md Yusof, Speaker of the Dewan Rakyat to discuss parliamentary and political funding reforms.

Representing IDEAS in the Media and Abroad

In 2019, the Unit grew to become a more trusted voice on good governance, democratic accountability and political analysis. Projek Pantau received some significant print media coverage and interest from RTM, Bernama, The New Straits Times, The Star, The Sun Daily, Tamil Mala and the Borneo Post. In the international arena, Unit Manager Aira Azhari spoke about the role of think tanks in advancing reforms in the 2019 Yushan Forum in Taipei, Taiwan. Research Executive Faiz Zaidi participated in the Southeast Asia Security Sector Governance Forum 2019 in Manila, Philippines. Both Faiz and Aira also represented IDEAS as Election Observers in the 2019 Indonesian General Elections in Jakarta, Indonesia.

Advancing a Competitive Economy



SMEs' Compliance Cost in Malaysia

Small and Medium Sized Enterprises (SMEs) are an integral part of the Malaysian economy, comprising nearly 40% of Gross Domestic Product (GDP) and a huge source of employment for the B40 (Bottom 40%) income groups. Yet, complying with government regulation constitutes a major burden in terms of increased operating costs for SMEs in Malaysia. In this paper, we detailed the results of a survey involving SMEs in Klang Valley to better grapple with the complexity of regulatory compliance, and subsequently to promote informed discussion on how to reduce them and translate savings into boosting income for the B40.

ASEAN Integration Report 2019

The ASEAN Prosperity Initiative (API) is designed to highlight issues and raise questions over the development of ASEAN and its role in supporting the prosperity of its Member States and their citizens. Following the API's inaugural report in 2018, the implementation progress of the ASEAN Economic Community (AEC) Blueprint 2025 was again revisited – if ASEAN has been making up lost ground or slipping further behind – culminating in the publication of the ASEAN Integration Report 2019.



According to the report, while more than half of the total 647 actions lines in the AEC Blueprint 2025 have been fully or partially implemented, only 17.7% of these action lines have been judged to be fully implemented. Further reflection is needed, as supported by surveys and stakeholder consultation, on improving the perception of the AEC and challenges to achieve progress in the most important areas.

GLC Monitor 2019: State of Play Since GE14

Before the general election in 2018, the Pakatan Harapan (PH) coalition promised to reform governance of government-linked companies (GLCs). These reforms included ensuring that the appointment of members of these boards of directors would be made based on merit, not on political considerations. In this GLC Monitor, we analysed the changes made to the ministerial reporting lines of selected GLCs and statutory bodies, and discussed its implication from a political economy perspective.

IDEAS will continue to address the question on the role of government in the economy through multi-disciplinary research, stakeholder consultation, media presence as well as public events.





2019 AT A GLANCE Further Influencing Policy Debates



In 2019 we consolidated and built on the changes of 2018. After some major developments in 2018 with the departure of our founding CEO and the move to our new office, we have expanded the team to meet the growing demand for independent analysis and research in Malaysia. We have also expanded our work into new areas focussing on our three overarching missions — advancing a competitive economy, ensuring trust in institutions and promoting an inclusive Malaysia.

Of course, 2018 was also a big year of change for Malaysia as a whole, with the first change of government since independence. In 2019, we played the role of support and critic as the government sought to implement its ambitious promises. We started the year welcoming the unveiling of the National Anti-Corruption Plan, an effort which has helped Malaysia to jump ten spaces in the Corruption Perception Index. Other areas however, have seen less progress — in 2019 we continued our long running campaign to reform Malaysia's Government Linked Companies (GLCs), a government promise that has not been implemented. In other areas too, we have tried to encourage reform, for example publishing a detailed analysis of the role of BERNAS to pressure the government to look hard at rice monopoly. Across all these areas we have maintained a close watch on the new government through our Projek Pantau, which monitors the promises made in *Buku Harapan* — early progress in 2018, has stalled a little in 2019.



In 2019, our work in social policy continued to expand. In April, we published a report on granting refugees the right to work, and we will continue to advocate for the rights of this community. We continued our work to ensure patients suffering from rare diseases are supported and were pleased to have the opportunity to work closely with the government as it develops a new policy. We look forward to the government's rare disease framework in 2020, an achievement made possible by the tireless work of the patient groups.

Looking beyond Malaysia's borders, we have continued to expand our regional work. For the second year, we published our ASEAN Integration Report this time in Bangkok, as part of our ASEAN Prosperity Initiative. We also worked with our partner think tanks in the region to assess the benefits and risks of growing Chinese investment in South East Asia. Finally, we have continued to engage on wider trade developments in the region – including the future direction of the Comprehensive and Progressive Trans-Pacific Partnership (CPTPP).

In 2020, we look forward to supporting much needed institutional reform, including the anticipated Political Financing and Procurement bills. We will further expand our efforts to ensure that Malaysia's development benefits everyone - assessing barriers to education for Orang Asli, advocating for refugee rights and supporting the development of the rare diseases framework. On the economy front, we will be stepping up our work on GLCs to ensure these issues are placed firmly in the national conversation ahead of the Twelfth Malaysia Plan and will be asking questions regarding the role of government in the economy more broadly. Further afield, we will continue our work on ASEAN integration and will be establishing a new regional project to monitor the Belt and Road Initiative. Throughout it all, we will continue to keep a close eye on all government reforms through Projek Pantau.
