As we have done before, we will always try to identify and highlight opportunities for cross-partisan working when it arises, while always being mindful that in a liberal democracy healthy competition between government and opposition is necessary to produce the best outcome for citizens.

Moving forward, we have formulated a new strategy revolving around our new theme "making markets work for the poor and underprivileged". We have formed three new units - education, aovernance and outreach - to ensure we have a clearer focus. The works of these units will gradually become more apparent in the months to come. But one thing is clear - to us, the free market principles can be applied to all aspects of public policy including education and governance. The concept of "markets" is not limited to economics only.

The mission of IDEAS is


to improve the level of understanding and acceptance of public policies based on the principles of rule of law, limited government, free markets and individual liberty

IDEAS' logo is a wau bulan that flies freely in the sky - which we call "Wau Bebas" or the Kite of Freedom. The traditional Wau Bebas motif symbolises IDEAS' belief that the principles of Rule of Law (Kedaulatan Undang-Undang), Limited Government (Kerajaan Terhad), Free Markets (Pasaran Bebas), and Free Individuals (Individu Merdeka), are deeply rooted in our nation's tradition and heritage.

Our task is to rediscover these truly Malaysian values and to represent them to contemporary Malaysian society so that our heritage will help us prosper in a globalised world. A wau is only complete and functional when it is rooted to the ground via a string, depicting our call for abidance to the rule of law within a small, limited state.

Tunku 'Abidin was educated at the Kuala Lumpur Alice Smith School, Marlborough College and the London School of Economics and Political Science, where he obtained his MSc in Comparative Politics in 2004. He worked in the UK Houses of Parliament before moving to Washington DC to join the World Bank as a Public Sector Consultant. Upon returning to Malaysia in 2008, Tunku 'Abidin worked at the United Nations Development Programme and the KRA Group before becoming a Research Fellow at the Lee Kuan Yew School of Public Policy at the National University of Singapore.

Throughout, he helped to develop the Institute for Democracy and Economic Affairs which he co-founded in 2006, and maintained his weekly columns: firstly

Abiding Times in the Sun, then Roaming Beyond the Fence in the Star and Sin Chew, and now Conservatively Speaking Freely in the Malay Mail, Borneo Post and Oriental Daily. Three books have been compiled from these articles.

Tunku 'Abidin also authored a book for the Installation of the Yang di-Pertuan Besar of Negeri Sembilan and led a major project to revitalise the State Anthem. He is a trustee of Yayasan Chow Kit, Yayasan Munarah and the Jeffrey Cheah Foundation; a contributor to the Foreign Policy Study Group and Yayasan Mahkota's Economic Roundtable; a member of the University of Malaya Research Advisory Committee; an advisor or patron to several cultural organisations; and an honorary major in the Malaysian Territorial Army.

Wan Saiful Wan Jan

Wan Saiful is Founding Chief Executive of IDEAS. He boarded at Sekolah Alam Shah, Kuala Lumpur, and then Tonbridge School, England. He holds a BA (Hons) in Management (Northumbria, UK) and an MSc in Research Methodologies (Middlesex, UK).

Wan Saiful lived in the United Kingdom between August 1993 and October 2009. There he worked for several organisations, including the think tank Commonwealth Policy Studies Unit, the British Conservative Party's Research Department, and Social Enterprise London. He was vice chair of Luton Conservative Association (2007-2009) and Head of Policy for the Conservative Muslim Forum (2007-2009). In May 2007, he contested in the English local elections as a Conservative Party candidate.

Currently, he is also Director of CfBT Education Malaysia; member of the Advisory Board at INTI University; member of the Advisory Board of University of Nottingham's School of Politics, History and International Relations; and member of the Ministry of Education - PEMUDAH Group on Education. He is also a member of the Mont Pelerin Society.

Previously he served as a member of the Razak School of Government's Academic Working Group; Director of ASLI Centre for Social Enterprise; and adjunct faculty at UCSI University's Faculty of Economics and Policy Science.

Firdaus, Founding Director of IDEAS, was educated at SRK Sultan Ibrahim Satu Pasir Mas, SRK Sri Subang Jaya and Sek Men Agama Persekutuan Kajang. He then went on to read Law at the University of Nottingham and BPP School of Law. He was previously Special Officer to the Chief Minister of Johor, handling the corporate portfolio which includes Iskandar Regional Development Authority and Johor Corporation.

Currently he is Vice President at JPMorgan Chase Bank Malaysia. He was a national delegate for Nottingham University to the National Union of Students (NUS), national executive member of Federation Of Student Islamic Societies (FOSIS), Chairman of Kesatuan Penuntut Undang Undang Malaysia UK & Eire (KPUM), and Chairman of UKEC (UK and Eire Council for Malaysian Students) from October 2005 to October 2007. As Chairman of UKEC, he established the first Malaysian Student Leaders Summit (MSLS), which has become a major national event. He is also founder of Young Corporate Malaysians and established the annual Young Corporate Malaysians Summit.

YEARS

The idea to establish a think tank for Malaysia was first mooted by three friends - Wan Saiful Wan Jan, Tunku Zain Al-'Abidin Tuanku Muhriz, and Wan Mohd Firdaus Wan Mohd Fuaad – in early 2006, having realised that there is a need to promote classical liberal ideas (known as libertarianism in United States of America) to Malaysians in a more strategic and organised fashion.



October 2006

We registered as a non-profit company limited by guarantee in England and Wales (Registration Number: 05980232). The 'working name' of the organisation was Malaysia Think Tank London (MTTL). It was established in London because all three founders were residing in England at that time. Our aim at this stage was to build our profile and fundraising.

June 2007


Upon receiving a grant of USD10,000 from Cato Institute, we began our work in Malaysia. The grant helped us to hold small seminars in Kuala Lumpur as well as opinion articles in Malaysian newspapers.

February 2008

We published our first book "Who Needs an Islamic State? (Second edition)" by Dr Abdelwahab El-Affendi, Senior Lecturer at the Centre for the Study of Democracy at the University of Westminster, London. The book was very well-received, and was reviewed in the British newspaper The Guardian.

July 2008

Another grant of USD35,000 from Cato Institute, USA, allowed us to launch WauBebas.org (Kite of Freedom), which served both as our website as well as the "brand" we used to promote libertarian ideas in Malaysia and Indonesia.



August 2008

Our first major event was the Akademi Merdeka (Freedom Academy), held on 23-25 August 2008 at Residence Hotel, UNITEN, Selangor, Malaysia. This was the first of many events that eventually evolved into our student outreach initiative in Malaysia and Indonesia under the banner of AkademiMerdeka.org.

January 2009

Our partnership with Cato Institute evolved into a partnership with Atlas Global Initiative for Free Trade, Peace and Prosperity, as Cato's International Programme moved to Atlas that year.

May 2009

We decided to move MTTL from London to Kuala Lumpur, and started building the foundations for a permanent home in Malaysia. Our first "office" was set up in a spare room in Tunku Abidin's apartment.

August 2009

After a comprehensive situational review, on 14 December 2009, we decided to relaunch the organisation with a new name that better reflects the areas of our work –

Institute for Democracy and Economic Affairs (IDEAS).





THE FIRST YEAR

2010 - The First Year

IDEAS was officially launched on Monday, 8 February 2010, at the Tunku Abdul Rahman Memorial, in conjunction with the birthday of Almarhum Tunku Abdul Rahman Putra Alhaj, Malaysia's first Prime Minister.







The event, which received wide coverage in the media, was attended by three generations of Tunku's family and more than 150 civil society leaders, captains of industries, politicians, senior government officials, representatives from the media and members of the public.


Tengku Razaleigh Hamzah, former Finance Minister of Malaysia, delivered the speech to officiate the launch.



THE FIRST YEAR

Establishing Our Presence

The year 2010 saw a fledgling IDEAS trying to establish ourselves in the Malaysian public policy scene. The two key areas that we focused on were school reform and federalism.















We started our research into the Malaysian school system. With funding from the CfBT Education Trust, UK, we conducted a review of the role of the private providers in the Malaysian school system.

THE FIRST YEAR

Throughout 2010, we organised 15 events, and spoke at eight more events organised by others, to inform the public about the values and importance of liberty and justice. We targeted rural areas and small towns, such as Muadzam Shah (Pahang), Batu Sapi (Sabah), Sibujaya (Sarawak) and Jitra (Kedah).

For an organisation that was in its first year, our media engagement was very successful. Our opinions were sought by journalists from both the national and international press, including Bernama, Reuters, AFP, and The Economist.







Our media achievements included:

- regular columns in six national press outlets
- seven TV and radio interviews
- 121 newspaper articles
- 55 mentions in printed news reports













THE FIRST YEAR

Regional Outreach

Under our *Akademi Merdeka* project, which is funded by the Atlas Economic Research Foundation, we held three residential courses for university students, two in Indonesia and one in Malaysia.





This enabled us to create a strong network with like-minded young activists in both countries.

THE FIRST YEAR

Remembering Malaysia's Founding Fathers



On 16 September 2010, in conjunction with the 47th anniversary of the formation of Malaysia, we hosted a special dinner with the descendants of Malaysia's founding fathers, including the children, grandchildren and great-grandchildren of Tunku Abdul Rahman, Tun Fuad Stephens, Tun Temenggong Jugah, Tun Tan Cheng Lock, Tun Sambanthan and Tun Dr Ismail. This was the first time since Malaysia Day in 1963 that so many members of these families were reunited under one roof.









We celebrated our anniversary on 8 February 2011 at the Tunku Abdul Rahman Memorial, in conjunction with the birthday of Almarhum Tunku Abdul Rahman Putra Alhaj. Just like our launch event in 2010, three generations of the Tunku's family graced this event too.







THE SECOND YEAR

Making Early Marks

January 2011 saw IDEAS making its first mark internationally. Despite our limited resources, we were ranked as the 18th best new think tank in the world for 2010 by the University of Pennsylvania's global think tank ranking programme.











Policy-makers in government and opposition started to recognise our potential. Among others, we were invited to make a presentation to a meeting on Budget 2012 chaired by Prime Minister YAB Dato' Sri Najib Tun Razak. And we also provided inputs to the Islamic Party of Malaysia (PAS) when they were formulating their concept of "Caring Nation" in preparation for the 13th General Election.



THE SECOND YEAR

Promoting School Reform

School reform quickly became our key agenda, especially the creation of greater choice and competition in the school system. Our effort was boosted significantly when we received a grant from Khazanah Nasional Berhad to start an education unit within IDEAS.





The Deputy Prime Minister and Minister of Education delivered a keynote speech at our National Conference on Public Private Partnership in the School System









THE SECOND YEAR

We worked with the Razak School of Government to hold three intensive workshops for senior officials from the Ministry of Education, with speakers including Harry Patrinos (World Bank) and Laura Lewis (CfBT Education Trust).







Encouraging Policy Debates

Despite the pervasive influence of race and religion in Malaysian politics, we continued our push to bring policy to the forefront of debates. We conducted workshops on rule of law and constitutionalism in five more states – Selangor, Johor, Sarawak, Sabah, Negeri Sembilan. Altogether 224 politicians and state party leaders attended our workshops.









We held and took part in 30 more seminars and conferences throughout the country, engaging an estimated 3000 people in total. Additionally, our outreach to university students was particularly successful. We visited six universities, holding workshops on "Understanding Economic Liberalisation" attended by at least 600 students and lecturers.









THE SECOND YEAR

Media engagement played a vital role in our outreach. In 2011, on average we were in the media every week, and generated RM34 million worth of PR Value in Malaysia alone through:

- regular columns in five national press outlets
- 97 TV and radio interviews and appearances
- 102 newspaper articles
- 646 mentions in printed news reports

We also began to see our voice published regionally, with the Economist, Singapore Straits Times and Jakarta Globe quoting us.





THE SECOND YEAR

Regional Outreach

We held three more residential courses in Indonesia under the banner of Akademi Merdeka plus six seminars for university students.





Our regional credentials were significantly boosted when we were chosen to host the 2011 Economic Freedom Network Asia Regional Conference, themed "Competition: Engine for Prosperity". This saw us co-publishing the Malaysian edition of the Economic Freedom of the World Annual Report, which was launched by Tan Sri Koh Tsu Koon, Minister in the Prime Minister's Department at the conference.

2012 - The Third Year

IDEAS' 2012 calendar started with our anniversary event on 11 February 2012, once again at the Tunku Abdul Rahman Memorial and graced by members of Almarhum Tunku Abdul Rahman Alhaj family.





At the event, Tun Mohd Dzaiddin Abdullah, former Chief Justice of Malaysia, delivered the keynote address, and Tunku Abdul Aziz Ibrahim delivered a passionate speech about remembering Tunku Abdul Rahman.

Increasing International and National Recognition

The year 2012 was a busy one for us. Early in the year, we were announced as the 13th best new think tank globally for 2011 by the University of Pennsylvania's global think tank ranking, which was an improvement from the year before.





Increasingly our work received national attention. Among others, we were invited to present our proposals to the Parliamentary Select Committee on Electoral Reform, spoke on how to reform the Dewan Negara to a group of 25 Senators, and organised a series of four lectures themed "Re-Imagining Malaysia" in partnership with the Universiti Malaysia Sarawak (UNIMAS) in Kota Samarahan.

We galvanised our efforts in the fields of governance and anti-corruption. We held a series of high-level roundtables on anti-corruption at the Malaysian Anti-Corruption Academy, and hosted a conference on eradicating corruption featuring former Prime Minister Tun Abdullah Haji Ahmad Badawi.









THE THIRD YEAR

We continued our efforts to upskill politicians, encouraging them to shift from the persistent debate about race and religion to real policies issues. In 2012, we conducted eight more workshops and seminars on constitutionalism and decentralisation for state-level politicians, this time in Perlis, Sarawak, Perak, Sabah, Negeri Sembilan and Pulau Pinang.







Our university outreach activities became more focused in 2012. In addition to the "Re-Imagining Malaysia" lecture series at Universiti Malaysia Sarawak, we conducted eight more seminars for students in various universities, to discuss the virtues of a liberal economic system. These are in addition to the many more events that we were invited to speak at in Malaysia.







We were also invited to speak at international events, including the World Forum in Governance organised by Brookings Institution in Prague, conference on economic Implications of the Arab Spring organised by Friedrich Naumann Foundation for Liberty in Tunis.

Right after the Malaysian Election Commission announced in May 2012 that they were appointing us as an accredited observer for Malaysia's 13th General Election, our media presence spiked. We generated more than RM63 million of PR Value (not including media outside Malaysia) through:

- regular columns in six national press outlets
- 129 TV and radio interviews and appearances
- 117 newspaper articles
- 590 mentions in regional news reports

Our opinions were also sought by regional and international media. We appeared on various platforms including the Asian Wall Street Journal, International Herald Tribune, The Telegraph (UK), The Guardian (UK), Jakarta Post, Singapore Straits Times, BBC, Al- Jazeera, Channel News Asia, and more.

Regional Outreach

Through Akademi Merdeka, we continued our university student outreach activities in Indonesia. In 2012 we organised 3 more residential courses and 8 student seminars, each one with the aim of promoting the free market and an open society.





We charted history on 9 July 2012 when we hosted President of Czech Republic Vaclav Klaus in Jakarta, at an event to launch the translation of his book on climate change.

2013 - The Fourth Year

In January 2013, we improved our position in the global ranking of think tanks produced by the University of Pennsylvania. This time, we were ranked as the 5th best new think tank globally and the best new think tank in Asia.



However we were unable to hold our anniversary event like in previous years, due to the heavy workload to recruit and train observers for Malaysia's 13th General Election. In fact, the first half of 2013 was completely dominated by preparation for observing the General Election and almost all our resources were dedicated to the project.



THE FOURTH YEAR

Observing Malaysia's 13th General Election

Although the Malaysian Election Commission started engaging us on 28 May 2012, we were only officially appointed as an accredited General Election observer on 31 January 2013. Nevertheless, this was a very significant appointment as it signifies the level of trust given to us nationally.







We recruited 325 observers to cover 99 (out of the 222) parliamentary constituencies, as well as the overseas voting processes in USA, UK, France, Switzerland, Hong Kong and the United Arab Emirates. We conducted 22 training sessions for these observers in just seven weeks, with at least one each in all the peninsular Malaysia states.

The General Election eventually took place on 5 May 2013. We produced our observation report on 8 May 2013. The report received widespread

coverage nationally and internationally. Our website crashed daily for almost two weeks due to the heavily increased number of visitors downloading the report.

This was a most challenging project for a small organisation like us. Managing the very high public expectation as well as maintaining our cross-partisanship were particularly complex. Nevertheless, we completed it successfully, with almost no one questioning the credibility and independence of our findings.









THE FOURTH YEAR

Continued Engagement With Society

We ramped up our outreach activities soon after the General Election. We toured the country to discuss the outcomes of the general election, and the impacts it may have on Malaysia and its position in the region.

In total, in 2013 we took part or organised 21 events in Malaysia to directly engage the public and policy-makers. We also held more activities for Malaysian students. In total we spoke at or organised nine seminars in for university students in Malaysia, and one residential course.











This year, we generated more than RM44 million of PR Value (not including media outside of Malaysia) through:

- regular columns in eight national press outlets
- 63 TV and radio interviews and appearances
- 105 newspaper articles
- 614 mentions in printed news reports





Regional Outreach

We spoke at four events outside of Malaysia - in Manila, Singapore, Bangkok, and London.

Our student engagement in Indonesia continued under the banner of Akademi Merdeka We hosted a few more residential courses and more seminars for university students.





Two Major Research Initiatives

2013 was a particularly good year in terms of our original research initiatives. We completed two research projects in education and governance.

Our Giving Voice to the Poor project was a nationwide survey of poor and underprivileged families (the bottom 40 percent). We conducted seven focus group discussions and interviewed a further 1200 parents, capturing their opinions of the current Malaysian education system, and the challenges they face in sending their children to school. The primary study was completed in November 2013, and reports will be released in stages in 2014.

We also coonducted another project that aimed to persuade the government to increase transparency in public procurement so that taxpayers know whether they are getting better value for money. We held a series of high-level meetings involving ministers and senior civil servants, and published a paper on the topic, all aimed at lobbying for improvements in transparency. We are glad that from late November 2013, the government has published some information regarding directly negotiated contracts on a government website.








TOTAL INCOME DISTRIBUTION 2010 - 2013
